What's The Difference?

In the United States, Zoom offers a separate platform called Zoom for Government, authorized at the FedRAMP Moderate Level. Although it is designed for federal agencies, Zoom for Government is also available to U.S. state and local government customers as well as other approved businesses and organizations that support their mission. The Zoom for Government platform is U.S.-based and managed by U.S. persons only.
