**Evaluation Methods Used:** The following testing was done on iPad iOS version 15.0 with Apples' Accessibility Display options (color inversion, grayscale, high contrast), Zoom option, VoiceOver option and Text options (larger text, bold text, on/off labels). Testing was also done on a Windows 10 with NV Access's NVDA screen reader v2016.1 to v2018.4, and JAWS screen reader v17.0 and v18.2, Microsoft Accessibility Options (Filter keys and Display/Contrast settings), and standard keyboard.
